Mona Abaza obtained her PhD in 1990 in sociology from the University of Bielefeld, Germany. She is currently Professor of Sociology at the American University in Cairo. From 2009 to 2011 she was Visiting Professor of Islamology in the Department of Theology, Lund University. She was a visiting scholar in Singapore at the Institute for South East Asian Studies (1990–1992), Kuala Lumpur (1995–1996), Paris (1994), Berlin (Wissenschaftskolleg 1996–1997), Leiden (2002–2003), Wassenaar (2006–2007) and Bellagio (Rockefeller Foundation 2005). Her books include *Twentieth Century Egyptian Art: The Private Collection of Sherwet Shafei* (2011), *The Changing Consumer Culture of Modern Egypt: Cairo's Urban Reshaping* (2006), *Debates on Islam and Knowledge in Malaysia and Egypt: Shifting Worlds* (2002) and *Islamic Education, Perceptions and Exchanges: Indonesian Students in Cairo* (1994).

Chris Berry is Professor of Film Studies at King's College London. Prior to his current appointment, he taught at La Trobe University in Melbourne; the University of California, Berkeley; and Goldsmiths, University of London. His publications include *Cinema and the National: China on Screen* (with Mary Farquhar, 2006), *Postsocialist Cinema in Post-Mao China: The Cultural Revolution after the Cultural Revolution* (2004), *The New Chinese Documentary Film Movement: For the Public Record* (edited with Lu Xinyu and Lisa Rofel, 2010), *Electronic Elsewheres: Media, Technology, and Social Space* (edited with Kim Soyoung and Lynn Spigel, 2010) and *Cultural Studies and Cultural Industries in Northeast Asia: What a Difference a Region Makes* (edited with Nicola Liscutin and Jonathan D. Mackintosh, 2009).

Michael Bull is a reader in media at the University of Sussex. He is the author of *Sounding Out the City: Personal Stereos and the Management of Everyday Life* (2000) and *Sound Moves: iPod Culture and Urban Experience* (2007). He and Les Back co-edited *The Auditory Culture Reader* (2003) and he is a founding editor of the journal *Senses and Society*. He is Director of the Centre for Material Digital Culture at Sussex and a core member

of the European think tank Future Trends Forum, based in Madrid. He is currently writing a monograph on the history of sonic connections.

Francesco Casetti is Professor of Film and Media at Yale University. He is the author of *Inside the Gaze: The Fiction Film and its Spectator* (1999), *Theories of Cinema, 1945–1995* (1999) and *Eye of the Century: Film, Experience, Modernity* (2008). He has been Visiting Professor at the University of Paris 3, University of Iowa and University of California, Berkeley. Casetti and Jane Gaines were the co-founders of the Permanent Seminar on Histories of Film Theories. He is the General Editor of the series “Spettacolo e Comunicazione”. He has taught for 30 years in Italy, where he served as President of the Association of Film and Television Teachers.

Beatriz Colomina is an architectural historian and theorist who has written extensively on questions of architecture and media. Her books include *Privacy and Publicity: Modern Architecture as Mass Media* (1994), which was awarded the 1995 International Book Award by the American Institute of Architects, *Sexuality and Space* (1992), which was awarded the 1993 International Book Award by the American Institute of Architects, and *Architectureproduction* (1988). She was selected to be a juror for the Venice Biennale (2010), and in the architectural competition for the new headquarters of Corporación Andina de Fomento in Caracas, Venezuela. She is the Founding Director of the Program in Media and Modernity at Princeton University. In 2006–2007 she curated, with PhD students, the exhibition “Clip/Stamp/Fold: The Radical Architecture of Little Magazines 196X–197X” at the Storefront for Art and Architecture in New York, and the Canadian Centre for Architecture in Montreal. The exhibition continues to travel around the world, most recently in the Museum of Design of Barcelona and the Colegio de Arquitectos de Murcia.

Anne M. Cronin is a senior lecturer in sociology at Lancaster University. She has published *Advertising and Consumer Citizenship* (2000), *Advertising Myths* (2004), *Advertising, Commercial Spaces and the Urban* (2010) and *Consuming the Entrepreneurial City* (co-edited with Kevin Hetherington, 2008). She is currently working on a project on friendship and spatiality.

Tamsin Dillon is Director of Art on the Underground. She is committed to an innovative and challenging practice, developing opportunities for artists to create new work, and for diverse audiences to experience art in contexts both within and beyond the confines of the museum

and gallery. Since 2003, she has developed Art on the Underground to deliver high-quality art projects with world-class artists through a range of project strands. Dillon was at Chisenhale Gallery, London, from 2000 to 2002 and prior to that worked in a range of institutions and contexts, including Whitechapel Gallery, London; Capp Street Project, San Francisco; Chelsea and Westminster Hospital, London; and Norbury Park, Surrey. She has taught and lectured at a range of cultural and educational institutions, including the Royal College of Art, Chelsea College of Art and the Camberwell College of Art.

Helen Grace established the MA Programme in Visual Culture Studies in the Department of Cultural and Religious Studies, Chinese University of Hong Kong and is currently Visiting Professor at the National Central University in Taiwan as well as Research Affiliate, Sydney College of the Arts and Associate, Department of Gender and Cultural Studies, University of Sydney. She is an award-winning filmmaker, photographer and new media producer, and her work is included in *A Different Temporality: Aspects of Australian Feminist Art Practice, 1975–1985*, Monash University Art Museum, 2011. Her recent works include *Speculation: The October Series*, (Articulate Project Space, Sydney, June–July-2012); *IPO: Emotional Economies* (John Batten Gallery, Hong Kong, May 2009); *Train of Thought* (Kiasma Museum of Contemporary Art, Helsinki, 2006). She is the author of the CD-ROM, *Before Utopia: A Non-Official Prehistory of the Present* (2000). She co-authored *Home/World: Space, Community and Marginality in Sydney's West* (1997) and edited *Aesthesis and the Economy of the Senses* (1996). Her current research is on ubiquitous media and user-created content, focusing on camera phone images in Hong Kong and China.

Janet Harbord is Professor of Film Studies at Queen Mary, University of London. She is the author of several books on film and philosophies of screen technologies in the digital age. She has been the recipient of collaborative grants from the EPSRC and AHRC for the project “MediaCity: Social Trends” (2009), and the Leverhulme-funded “Tracking the Moving Image: Screens in Public Space in Cairo, London and Shanghai” (2009–2011). Her current project is a book on Giorgio Agamben and film entitled *Ex-centric Cinema*.

Zlatan Krajina worked as an associate lecturer in media and communications at Goldsmiths, University of London, and is currently based at the University of Zagreb, where he teaches postgraduate modules on

"media cities" and media audiences. His work explores issues concerning screen technologies, social space, mobility and experience.

Marysia Lewandowska is a Polish-born artist based in London since 1985 who, through her collaborative projects, has explored the public function of media archives, collections and exhibitions. She collaborated with Neil Cummings between 1995 and 2008. Research has played a central part in all of her projects, which include the book *The Value of Things* (2000), and "Capital" (2001), which inaugurated the "Contemporary Interventions" series at Tate Modern (2001). The "Enthusiasm" project was shown at the CCA (Warsaw), Whitechapel Gallery (London), Kunst Werke (Berlin) and the Tapies Foundation (Barcelona) in 2005–2006. The film *Museum Futures: Distributed* was shown at the Moderna Museet (Stockholm) in 2008, and *Tender Museum* was shown at the Muzeum Sztuki (Lodz) in 2009. Intellectual property was a focus of a recent project entitled "How Public Is the Public Museum?" commissioned by the Moderna Museet (Stockholm) in 2010. Questions of ownership and the art world are the subject of the forthcoming book *Undoing Property*, to be published in 2013.

Rachel Moore teaches in the Media and Communications Department at Goldsmiths, University of London. She received a John Simon Guggenheim Fellowship for her current project, "In the Film Archive of Natural-History," which investigates the use of old movies and footage in current artistic practice, a portion of which was published as "Love Machines" in *Film Studies* 4. She is the author of *Hollis Frampton: (Nostalgia)* (2006), *Savage Theory: Cinema as Modern Magic* (2000), as well as articles on Patrick Keiller (*LUXonline*), James Benning and Kenneth Anger (*Afterall*). She is a member of the Leverhulme "Spaces of Media" project investigating the use of screens in urban spaces today.

Lisa Parks is Professor of Film and Media Studies at the University of California, Santa Barbara. Her research explores uses of TV, satellite and computer technologies in transnational contexts. She is the author of *Cultures in Orbit: Satellites and the Televisual* (2005) and co-editor of *Planet TV* (2003), *Undead TV* (2007) and *Down to Earth: Satellite Technologies, Industries and Cultures* (2012). She is currently working on two new books: *Coverage: Media Space and Security after 9/11* and *Mixed Signals: Media Infrastructures and Cultural Geographies*.
